OIL-METHOD OF DEVELOPMENT OF TAR SANDS

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): In view of the fact that the situation which now applies to natural gas may in the not too distant future apply to oil, may I ask the minister whether the government is contemplating making any offers to the provinces of Alberta and Saskatchewan for some public participation in the development of the tar sands in those two provinces?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, the hon. gentleman may know that the government of Alberta made a new and interesting proposal last night with regard to state participation in the oil industry. I expect to be meeting with representatives of that province in the near future to discuss the possible further development of the oil sands, and development in Saskatchewan as well.

EXEMPTION OF TAR SANDS OIL FROM SURTAX

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I have a supplementary question for the minister. In light of his answer, has the government now established a policy, in view of the proposed sharing of the development of the Athabasca tar sands by business and the people, that will ensure that crude petroleum produced from this particular development will be exempted from the surtax?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, that is one of the questions that has been discussed but no conclusion has been reached yet. There is some question whether specific exemption would be necessary in light of anticipated price levels.

Mr. Woolliams: Mr. Speaker, may I follow that up. The minister said that there is some question. Would he enlighten the House and people interested throughout the country as to what is the question that concerns him in this regard and why he cannot categorically say now whether the crude petroleum produced by that development will be exempt from the surtax?

Mr. Macdonald (Rosedale): I should like to have very full consultations with the government of Alberta before making that statement, Mr. Speaker.
