Due to variations in both the anticipated usage and delivery time, a safety stock is required in addition to the above to ensure that the majority of customer demands can be filled. In so far as DSS is concerned, a safety stock level of 28 days of anticipated sales based on historical usage data is maintained for each stocked item in the inventory.
