That in respect to the Pickering airport properties, this House instruct the Minister of Public Works to take whatever action is necessary to advance the valuation date for those in occupation at the time of the original notice of confirmation to the date that such persons replaced their properties, or the date the Crown takes physical possession of such properties, whichever is the earlier, as one step in assuring that expropriated persons are provided with reasonably equivalent premises to replace those which have been taken from them.
