Question No. 362-Mr. St. Germain:

FEDERAL-PROVINCIAL LEGAL AID AGREEMENTS

Ouestion No. 385-Mr. Howie:

Will the Government renegotiate the federal-provincial legal aid agreements and what is the estimated cost to Canada of this renegotiation?

Hon. Mark MacGuigan (Minister of Justice): In so far as the Department of Justice is concerned: the Federal-Provincial Criminal Legal Aid Agreements are currently under renegotiation with all ten provinces. Canada has made an offer to the provinces which for 1983-84 will increase Canada's total contribution to over \$40M. This is an increase of \$12M, or 43 per cent, over what was due in 1982-83 under the old agreement. In 1984-85, Canada's contribution will increase to \$45M.

These amounts do not include additional financial assistance to be provided to the provinces for legal aid services to young offenders, required as a result of the proclamation of the Young Offenders Act on April 1, 1984. This additional cost sharing is currently under negotiation with the provinces.

STUDY OF ADMINISTRATIVE LAW TRIBUNALS

Ouestion No. 389-Mr. Howie:

Did the Department of Justice undertake a study of administrative law tribunals and, if so, what was (a) the time frame of the study (b) the estimated cost (c) the purpose of the study?

Hon. Mark MacGuigan (Minister of Justice): In so far as the Department of Justice is concerned:

- 1. (a) Yes, the Department of Justice is studying federal administrative tribunals in the context of a three-year administrative law reform project that began in fiscal year 1983-84 and is expected to continue through fiscal year 1985-86.
 - (b) The estimated cost of the entire project is \$850,000.
- (c) Project staff and consultants are doing research and preparing recommendations on the following subjects:
- 1. the rationalization of social benefits appeals tribunals;
- 2. minimum uniform guidelines on administrative procedure for tribunals and the feasibility of establishing an advisory council on tribunals:
- 3. revisions to the Statutory Instruments Act;
- 4. law concerning the Crown, including Crown proceedings and immunities, prerogatives, privileges and liabilities.
