## "THE CAR ECONOMY BOOK"

### Question No. 351-Mr. St. Germain:

Did the Department of Energy, Mines and Resources publish "The Car Economy Book", and, if so at what cost for (a) concept and research (b) production (c) printing (d) distribution and what was the total cost of the publication?

- Mr. Leonard Hopkins (Parliamentary Secretary to Minister of Energy, Mines and Resources): Yes, EM&R published "The Car Economy Book" in October, 1981.
- (a) The publication was developed and written within EM&R in consultation with Transport Canada. No outside costs were incurred.
- (b) Artwork was designed and produced within EM&R. Typesetting costs amounted to \$1,300.
- (c) Total printing costs were \$180,000 for 600,000 English and 300,000 French copies.
- (d) The publication was distributed through the EM&R exhibit program and through the Department's publication distribution facilities at headquarters and in the regions. No special distribution costs were incurred.

Total cost of the publication was \$181,300.

- 2. The average annual market price (steers and heifers combined) for the five years prior to 1983 was \$73.70/cwt.
- 3. The average support price for the five years prior to 1983 was \$65.92/cwt.
