OCCUPATIONAL HEALTH AND SAFETY

SMOKING IN FEDERAL BUILDINGS—GOVERNMENT APPEAL AGAINST BOARD DECISION

Hon. Chas. L. Caccia (Davenport): I have a question for the Minister of National Health and Welfare to brighten up his morning and inject some life into it. As the Minister knows, the staff relations board decision to confine tobacco smoke in federal buildings to separately ventilated areas for smokers is being appealed by the federal Government. Will he stop the appeal?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, I have had a wonderful morning and I have met very many interesting people. I hope my contribution to the Hon. Member's morning will finally give him some light as well. We are encouraging federal Departments to follow the lead that has been taken, not only in my Department but in a few other agencies and Departments of Government as well, and simply declare workplace areas "smoke free".

With regard to the specific case to which the Hon. Member refers, it is a different approach in which one could only do what was done in Health and Welfare if one also conforms to the physical requirements of that earlier judgment. That created some difficulties—not the principle that we would like to see smoke-free areas throughout the federal Government.
