## UNIVERSAL ACCESS TO FAIR ORAL HEARINGS BEFORE REFUGEE BOARD

**Mr. Dan Heap (Spadina):** Mr. Speaker, I have another petition from a number of residents of Toronto, Scarborough, Richmond Hill and other parts of Ontario who point out that Canada needs to improve its standard of refugee protection and to adopt the proposal of the standing committee tabled 18 months ago, supported by the major religious groups in Canada, the Bar Association and other groups. Therefore they humbly pray and call upon Parliament to enact legislation which will embody the principle of fair and complete oral hearings of claimants before a refugee board independent of the Immigration Commission. There should be universal access to such hearings by every claimant, and there should be a fair chance for those concerned to arrive in Canada to present their claim.

## SMOKING—HEALTH HAZARD

**Mr. Dan Heap (Spadina):** Mr. Speaker, I also have a petition from residents of Burlington, Willowdale, Oakville, Hamilton, Toronto, St. Clair Beach, Kingsville, Amherstburg and other parts of Ontario. They point out that cigarette smoking is Canada's major preventable health hazard responsible for 35,000 Canadian deaths each year. They request attention to Bill C-204 which seeks to protect the health of Canadians by restricting the promotion of tobacco, guaranteeing smoke-free air to Canadian workers and travellers, and call upon Parliament to enact the non-smokers' health Act, Bill C-204.

**Ms. Lynn McDonald (Broadview—Greenwood):** Mr. Speaker, I have the honour to present a number of petitions. I am pleased by the support growing across the country from health agencies and concerned Canadians for Bill C-204, the non-smokers' health act. The petitioners are Ontario residents and they point out that cigarette smoking is Canada's major preventable health hazard, responsible for the deaths of some 35,000 Canadians every year. They point out that secondary smoke is implicated in the deaths of 500 involuntary smokers each year. Bill C-204 seeks to protect the health of Canadians by restricting the promotion of tobacco and guaranteeing smoke-free air to Canadian workers and travellers. They ask the House to enact Bill C-204.

## OPPOSITION TO PROPOSED CHANGES TO PATENT ACT

**Ms. Lynn McDonald (Broadview—Greenwood):** Mr. Speaker, I also have the honour to present another petition largely from citizens in my own riding of Broadview—Greenwood. The federal Government's proposals to change the Patent Act relating to prescription drugs will increase drug

prices for Canadian consumers and restrict the ability of average Canadians to buy necessary prescription drugs. Accordingly, the petitioners call upon Parliament to reject these proposals which will increase prescription drug prices for Canadians.

## SUPPORT FOR NON-SMOKERS HEALTH ACT

**Ms. Pauline Jewett (New Westminster—Coquitlam):** Mr. Speaker, I have a petition from residents of my own riding of New Westminster—Coquitlam, in Port Coquitlam, Port Moody, Burnaby, Maple Ridge, Surrey and Delta, some 90 signatories in all. They humbly pray and call upon Parliament to enact the Non-Smokers' Health Act, Bill C-204, introduced by my colleague, the Hon. Member for Broadview—Greenwood (Ms. McDonald). That Act seeks to protect the health of Canadians by restricting the promotion of tobacco and guaranteeing smoke-free air to Canadian workers and travellers. It is my duty to present this petition.
