# OPPOSITION TO CERTAIN CHANGES CONCERNING THE UNEMPLOYMENT INSURANCE PROGRAM

Hon. André Ouellet (Papineau—Saint-Michel): Mr. Speaker, I have another petition which it is my privilege to present on behalf of the constituents of the riding of Papineau—Saint-Michel, who signed this petition at the invitation of my colleague, the Hon. Member for Notre-Dame-de-Grâce (Mr. Allmand). The undersigned believe that the Government of Canada erred in its proposals to make considerable cuts in unemployment insurance benefits, to impose stricter conditions for eligibility and to reduce the benefit period.

The undersigned are particularly incensed that the Canadian Government will stop paying its share of \$2.9 billion into the unemployment insurance fund, leaving the program's financing up to workers and their employers.
