Petitions

The Government is withdrawing its contribution of \$2.9 billion to the unemployment insurance fund, leaving the financing to workers and employers, which means an increase in premiums for the employers and employees.

The Government is making other changes to the unemployment insurance system. These changes, along with the closure of CFB Summerside, will mean the loss of millions of dollars to the economy of Prince Edward Island.
