FRUITS OF PERSONAL INVESTIGATION.

"The American seldom invests in Canadian undertakings as a mere speculation, the results of which he leaves in the hands of others; but he comes over himself, and watches the application of the capital he and his friends have decided to apply to any undertaking." This was a significant sentence in the admirable paper of Mr. C. J. Just, one of Canada's active representatives in London, read before the United Wards Club of the city of London. Mr. Just strongly insisted upon the chances of the small working capitalist in almost any one of the industrial centres; and this both in old concerns requiring to expand, or in new ventures, as might be dictated by the needs of the situation, which could be readily diagnosed. An expenditure of £60,000,000 on railways alone within the next five or six years might well be considered the best guarantee for almost every form of manufacturing industry.
