Briand Completes His Cabinet

For the eighth time in his long political career Aristide Briand has assumed the office of French Premier. Following the retirement of Painleve on a want of confidence vote, Briand declined the President's invitation to form a cabinet, and only consented after unsuccessful attempts had been made by Herriot, the leader of the Radical faction, and by Senator Paul Doumer, a statesman who during the past thirty years has been prominently identified with French politics and who in 1906 was a candidate for the presidency.

Premier Briand's position is anything but a sinecure, and the circumstances under which he takes office do not make for security unless he can find an early solution for the problems with which the Government is confronted.

The immediate difficulties, it would appear, are not so much of a political nature as financial. In order to meet certain short term bonds maturing on December 8th, Premier Painleve sought the approval of the Chamber of Deputies to a proposal to raise the limit of the advances by the Bank of France. Considerable discussion took place and eventually on a vote of confidence the proposal was approved, but just as a motion to that effect was about to be adopted, one of the members made the charge that the banks had received advance information of the Government's intention and had used it to their advantage in speculating. Another vote of confidence placed Painleve in the minority and he withdrew.

Owing to the existence in the Chamber of Deputies of several parties, the position of leader is always more or less uncertain, and at this juncture, when it is necessary for France to raise large sums immediately to meet pressing obligations it is particularly difficult for him to steer a safe course. Caillaux attempted to relieve the situation by raising a gold loan, but only about one-third of the amount was subscribed. The Socialists were determined upon a Capital Levy, and Painleve's scheme, which appears to have been devised to avoid that expedient, included the formation of a sinking fund to meet the debt in fourteen years. This would have entailed a considerable increase in direct taxation, to which the French people have a rooted aversion.

The rehabilitation of the finances of the country is a matter which demands immediate attention, and it will be interesting to learn what method will be decided upon by the new Cabinet. Premier Briand takes office flushed with the triumph of Locarno, in consequence of which he is regarded as the man of the moment, and such is the effect of popularity that it may be that the people will accept from him a dictum which from another would receive scant consideration.

Collection for Christian Brothers Shows Increase

A total of \$2,751.45 was collected yesterday for the Christian Brothers. The amount, an increase of \$205.32 over last year's collection, was made up as follows:—

Following last Mass at the Cathedral, those who had taken up the collection, assembled at Mount St. Francis and formally handed over the collection. Mr. J. C. Pippy presided over the meeting and expressed his pleasure at being in a position to announce that the sum realized was an increase over last year's amount. He was glad for three reasons: First because the result showed appreciation of the work of the Brothers; secondly, that this year completes fifty years of labor in this country, for the order, and thirdly, because this year there is a new Superior, Rev. Bro. O'Hehir, whom he felt, would follow worthily in the footsteps of the eminent men who had gone before him. Since last year four men who had always been prominently identified with the collection had passed away in the persons of Hon. J. D. Ryan, Messrs. James P. Parker, M. O'Flanagan and Nicholas Walsh, and the speaker paid a tribute to their memory. This year is the fiftieth anniversary of the arrival of the Brothers in Newfoundland and it is fitting that the jubilee should be celebrated in some manner. Some plans are being laid for a celebration to be held in January and only awaited the arrival of Hon. W. J. Higgins to be formulated.

Rev. Brother O'Hehir, Superior of the Monastery, in accepting the collection, paid a tribute to the people whose generosity showed a splendid spirit of co-operation in the work of the order. He thanked all who had in any way helped towards the day's success, especially the press and all those who had written letters to the press reminding those people out of town and out of the country of the annual event.

M. Bambrick, on behalf of St. Patrick's, congratulated the Brothers on the magnificent result, but the collection is small, he said, compared with the amount of work the Brothers are doing in the community. He hoped that as the years go on the collection will continue to increase.

Mr. W. E. Brophy was pleased that the collection at St. Joseph's had increased in proportion with the other Parishes, and he wanted to say how glad the people of that parish were that the collection was so large. He referred to the deaths of Messrs. Ryan, Parker, O'Flanagan and Walsh and thought that it would be a good idea that the body of collectors present should remember them on the day by saying a prayer for the repose of their souls. The prayer was said and the entire gathering in a very feeling manner, and it was an impressive moment.

Rev. Brother Ennis spoke on behalf of Mount Cashel and he too, was glad that the results were so satisfactory. As the years go on and the work increases, more Brothers are required, and to-day in the community there are twenty Brothers whose efforts are meeting with much success.

Other speakers were Dr. V. P. Burke, Deputy Minister of Education, Mr. J. G. Higgins, who spoke on behalf of the Knights of Columbus and St. Bonaventure's Alumni, Rev. Bro. Ryan, Principal of St. Bon's College, and C. J. Cahill, M.H.A. All paid glowing tributes to the work being done by the Brothers, to the splendid results attained during the past six years during which Rev. Brother Ahern was superior, to Rev. Bro. O'Hehir's worth, and the confidence was expressed that his term of office will be in line with the noble men in whose footsteps he is following. With regard to the jubilee celebration, the hope was expressed that it will take the form of an international affair, whereby every Christian Brother boy, no matter where he is, be he a past pupil of Holy Cross, Mount Cashel, St. Patrick's Hall or St. Bonaventure's College, be permitted to take part and show his appreciation of the self-sacrifice of the noble order who have given up their entire lives for the cause of Christian education.

AT SAINT PATRICK'S.
After last Mass a large number of the friends and supporters of Holy Cross resorted to the schoolroom of Holy Cross, where the presents received by Mr. Bambrick, Chairman of the West End Collection Committee announced the result of the collection in that parish as \$2,890.39, an increase of \$33.24 over the previous year. He heartily congratulated the Brothers on the success of the collection and paid a high tribute to their work.

Rev. Brother Egan, Principal of Holy Cross, on behalf of the Brothers, eloquently thanked the people for their

generosity displayed and gave a learned address on true education, monasticism in the western world, and a necessarily brief review of the work of the Brothers in Newfoundland since the arrival of Rev. Brother Holland, on October 4th, 1875. St. John's was the foundation of the American Province of the Brothers which now includes some 50 Newfoundlanders though the Novitiate was opened only ten years ago. Brother Egan also expressed thanks to the generous friends of other denominations, and sympathy to the relatives of Messrs. John Doyle, Peter Neville, John J. Flynn and M. Mullins, friends of Holy Cross, who had died during the year.

Secretary J. Doyle, of the Collection Committee thanked Brother Egan for the kindly references to the work of his father who had been associated with the Brothers both in Ireland and this country. On behalf of the Committee he thanked the donors of the collection and the attainment of their jubilee which comes in January.

A meeting of Holy Cross Institute was held when the following motion was passed by J. Barron, seconded by J. J. Rosier, supported by J. Fitzgibbon, and spoken to by F. Murphy, was unanimously adopted:—
"That the Executive of Holy Cross Committee be appointed to enquire into, and consider the part of the friends and supporters of Holy Cross should take in the coming jubilee."

The different speakers voiced the necessity of marking the occasion in a fitting manner and Chairman J. Madigan assured the gathering that the matter would be given the earliest attention by the Executive who will report their views later.

Voices of thanks were passed to the press for the assistance towards the collection, and Rev. P. J. Kennedy for his appeal of yesterday week, and the meeting closed with songs by Messrs. W. Aylward, R. J. Power and M. Murphy.

Magistrate's Court

SATURDAY AFTERNOON SESSION.

The adjourned hearing of the Board of Liquors Control vs. Miss M. Pever, the Proprietress of a West End shop, for a breach of Section 25, of the Alcoholic Liquors Act, concluded in the Magistrate's Court on Saturday afternoon, when the defendant was convicted and fined \$10.00, or in default, 30 days imprisonment. Three witnesses were called for the prosecution. The first was Detective Walsh who corroborated what Detective Lee had stated on the previous day in connection with a seizure being made on the premises on the afternoon of November 14th, when eight bottles of rum were confiscated. The next witness was David Cooper, a frequent visitor to defendant's shop. He said candy, soft drink, tobacco's, etc., were offered for sale. He never bought any liquor there and did not know of any sold on the premises. Witness denied having received any correspondence from the accused in connection with the case, and stated that the Crown, Hugh Ford, who had visited accused's store from time to time, stated to the court that he had seen some correspondence in connection with liquor on one of his visits to the shop, but as he did not know whether it was defendant's handwriting or not, this evidence was not taken. At this juncture the Crown case concluded and Mr. Browne asked for a dismissal of the charge, but the court, in connection with the eight bottles of rum found on the premises. She named five men who were the owners of one bottle each, and of whom worked at the Dry Dock. They had left the liquor during the morning of the 14th, and intended to return for same later in the day. Three other bottles were also left there in the same manner. Defendant was unable to give any explanation of the rum, and stated that she would be able to recognize them when they next visited her store. She claimed one of the two bottles done up in the parcel was her own property and the other belonged to a Miss James. The latter woman belongs to an outpost, witness stated, and she was only slightly acquainted with her. The part bottle of liquor was owned by a Mr. Squires. Mr. Parsons put the defendant through a most searching cross-examination. Several questions were asked witness in connection with the bottle purported to be owned by her, and on this point her statements did not appear to be satisfactory to the Court. An independent witness was then called, which was the police. Judge Morris, stated, that the defendant had not given to the court a satisfactory explanation of the rum, and that she could not remember the owners of the three bottles was not satisfactory. Sentence was then handed down as already mentioned. The fine was paid.
