EFFORTS TO CALM HER IN VAIN

New York, June 26 .- A terrifying dream, one of many such that had unher, frightened Miss Mary Hendrickson to death on Saturday night. The luckless young woman lived at No. 411 Cumberland street, Brooklyn. The last terrifying dream was fatal to her because she suffered to recover from the shock dealt by her sleeping vision, soon ceased to

Miss Hendrickson, who was still at school, never had robust health. About six months ago a nightmare intensely alarmed her. Again and again horrible dreams awakened her trembling. Yet as soon as she recovered her waking senses she forgot what had so greatly terrified her

"I have no idea what caused these nightmares," said the girl's father, Henry Hendrickson, a traveling salesman. "Often, after one of them, her mother and I soothed her and then asked her what she had dreamed. Always she was so frightened she could not tell us. Her dread seemed to deprive her of memory for the time being. Yet, often after one of these nightmares, Mary was very nervous and distracted for a day or two." STARTLED BY A SHRIEK.

On the advice of a physician Miss Hendrickson slept in a room opening from her parents' bedroom. The family retired about 9:30 o'clock on Saturday night. Two hours later a piercing shriek startled Mr. and Mrs. Hendrickson from their sleep. Springing from bed they lighted the gas. They saw their daughter, in her nightrobe, standing erect in her bed. Wide-staring the girl glared straight before her; an expression of terror disfigured her face. They tenderly spoke to her and sought to pacify her. She sank to the bed, pale and quivering, seemingly exhausted. For a minute or two her breath came quick and shallow—like one breathes who con-fronts a deadly danger.

Windsor, June 26.-J. L. Murphy, of the legal firm of Murphy, Saie & O'Connor, has won a signal victory over the Bell Telephone Company of Canada, and it may have a far-reaching effect on the company.
Some months ago Mr. Murphy re-

fused to sign a contract to secure telephone connection with his office. The telephone people had his connections cut, and he applied for and secured as injunction compelling the cured an injunction compelling the company to give him the same service as other patrons until the trial of the action.

The plaintiff contended that the company had no right to demand of from heart disease.
