61. Resolved, That a sum not exceeding five-sixths of Thirteen thousand dollars be granted to His Majesty, for Miscellaneous—Expenses of litigated matters connected within the Department of Justice, for the year ending 31st March, 1919.

62. Resolved, That a sum not exceeding five-sixths of Five hundred dollars be granted to His Majesty, for Miscellaneous—Annual contribution to the Canadian Law Library, London, England, for the year ending 31st March, 1919.

63. Resolved, That a sum not exceeding five-sixths of Five hundred dollars be granted to His Majesty, for Miscellaneous—Consolidation and publication of Reports, Orders in Council and correspondence upon Provincial Legislation, since 1905 (Revote), for the year ending 31st March, 1919.

64. Resolved, That a sum not exceeding five-sixths of Five thousand dollars be granted to His Majesty, for Miscellaneous—Expenses under the Pecuniary Claims Convention with the United States (Revote), for the year ending 31st March, 1919.

65. Resolved, That a sum not exceeding five-sixths of Five hundred dollars be granted to His Majesty, for Miscellaneous—Grant to Chief Constables' Association of Canada, for the year ending 31st March, 1919.
