to clover seeds and to furniture, similar concessions are embodied in the trade agreement with France, so that no further reductions will be extended to most favoured nations by the granting to Poland of the concessions respecting these products. The other concessions granted to Poland relate to the following products:

Canned hams;

Dried mushrooms; Manufactures of alabaster, n.o.p.;

Cut, pressed, moulded or crystal glass table-ware, decorated or not;

Blown glass tableware and other cut glass ware:

Horse hair, curled or dyed, n.o.p.;
Trunks, valises, hat boxes, carpet bags, tool
bags and baskets of all kinds, n.o.p.; Ornaments, statues and statuettes

alabaster.

When the convention comes into force the duties on these products, imported from countries entitled to most favoured nation treatment, will be reduced to the extent of the discounts from the intermediate tariff specified in schedule B.

I shall be pleased to answer any question I may concerning the different sections, as

they are reached.

Section agreed to.

On section 2—Convention approved.

Mr. MACKENZIE KING: As I understood the minister's explanation, so far as duties are concerned, goods coming from Poland are now to come in free or at a lower rate of duty than exists at the present time.

Mr. HANSON (York-Sunbury): In all cases most favoured nation treatment has been given except in nine, where the duties are even lower, and in other cases they are free.

Mr. MACKENZIE KING: I must congratulate the government in having come around to the correct point of view in regard to tariffs. It may be a deathbed repentance, but it is just as well to have it.

Mr. HANSON (York-Sunbury): That is a matter of opinion.

Section 2 agreed to.

Sections 3 to 5 inclusive agreed to.

Schedules agreed to.

Bill reported, read the third time and passed.

DOMINION HOUSING ACT

CONCURRENCE IN SENATE AMENDMENT

Right Hon. R. B. BENNETT (Prime Minister) moved the second reading of and concurrence in an amendment made by the Senate to Bill No. 112, to assist the construction of houses.

He said: There has been but one amendment made by the Senate, and I just asked the opinion of the right hon. gentleman opposite whether he thought the amendment was better than the original wording. Paragraph (d) of section 2 as it passed this house read as follows:

"Housing scheme" means a scheme for the construction of houses and their occupation by tenants or purchasers.

The Senate has concluded to add between the words "and" and "their" in the seventeenth line the word "for," so it will now read:

"Housing scheme" means a scheme for the construction of houses and for their occupation by tenants or purchasers.

That is the only amendment.

Motion agreed to; amendment read the second time and concurred in.

FRUIT, VEGETABLES AND HONEY ACT

CONCURRENCE IN SENATE AMENDMENTS

Right Hon. R. B. BENNETT (Prime Minister) moved the second reading of and concurrence in amendments made by the Senate to Bill No. 95, respecting fruit, vegetables and honey.

He said: The amendments made by the Senate are very slight. The word "establishment" is defined in the second section of the act as follows:

"establishment" means any plant, factory or premises in which produce is canned or preserved for food for export.

And "export" is defined as:

"export" means export out of Canada or out of any province to any other province thereof.

The Senate amendment defines "establishment" as

"establishment" means any plant, factory or premises in which produce is canned or preserved for food for export or interprovincial trade.

The words "or interprovincial trade" are added. The Senate has amended the definition of "export" to read:

"export or interprovincial trade" means shipment out of Canada or out of any province to any other province thereof.

Then section 10 of the bill and succeeding sections have been amended by the use of three words somewhat different from what we used to express the necessity for licensing. Section 10 reads:

No commission agent shall accept or offer to accept for sale on commission or otherwise deal
