Mr. Speaker: Order. The hon. member cannot make a statement. He should explain as briefly as possible why the document cannot be produced.

Mr. McNulty: In the circumstances we would respectfully ask the hon. member to withdraw his motion.

Mr. Skoberg: I agree. Perhaps the hon. member would complete his explanation later today.

Mr. Speaker: Motion dropped.

Order discharged and motion withdrawn.

REPORTS ON CONFERENCE OF INDIAN CHIEFS
AT KAMLOOPS

Motion No. 357-Mr. Howard (Skeena):

That an Order of the House do issue for a copy of all reports prepared by any employee of the Government of Canada or any agency, department or branch thereof and specifically, a Mr. Glynn and a Mr. Smith, who attended the Conference of Chiefs held in Kamloops, B.C. from November 17 to 22, 1969.

Mr. Russell C. Honey (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): Mr. Speaker, the report the hon. member is requesting was prepared by departmental offiicals on a confidential basis for the information of senior officers of the department and is privileged. I regret that I cannot accede to the hon. member's request and I would ask that he withdraw the motion.

Mr. Speaker: Transferred for debate.

Mr. Howard (Skeena): Mr. Speaker, I did not ask that it be transferred for debate.

Mr. Honey: I do.

Mr. Speaker: It has been requested that it be transferred for debate.

Mr. Howard (Skeena): Mr. Speaker, I should like to rise on a point of order which relates to the specific request of the hon. member that the motion be transferred for debate. My point of order also relates to Standing Order 48(1) which provides that Notices of Motions for the Production of Papers should be placed under a certain heading, and then states as follows;

All such notices, when called, shall be forthwith disposed of; but if on any such motion a debate be desired by the members opposing it or by a Minister of the Crown, the motion will be transferred by the Clerk to the Order of "Notices of Motions (Papers)".

The key point here is found in the words "forthwith disposed of", coupled with the fact that I do not desire any debate and did not request that the motion be transferred for debate. The Parliamentary Secretary—whether he is a minister or not may not be too
