sooner the danger of unemployment would recede.

An hon. Member: That is a new theory.

Mr. Orlikow: A further supplementary question, Mr. Speaker. Since unemployment is rising and inflation is continuing to increase, can the House take it that the Prime Minister has no intention of relaxing the program of restraint regardless of whether unemployment continues to rise at an increasing rate?

Mr. Trudeau: Mr. Speaker, I realize that the opposition has some difficulty in making choices, but the government is faced with the choice of either giving up the fight against inflation or continuing it. I want to reassure the House and country that it would be no problem at all for the government to spend many, many more millions of dollars in all parts of the country if it lacked the courage to continue the fight against inflation, as apparently seems to be the case with the opposition.

Mr. Donald MacInnis (Cape Breton-East Richmond): Mr. Speaker, I have a further supplementary question for the Prime Minister who has referred to the difficulties of the opposition. Is he not aware that the Minister of Regional Economic Expansion, before the Standing Committee on Regional Development just the other day, had occasion to say that he was not defending the government's policy?
