Hon. G. J. McIlraith (Acting Prime Minister): The statement has caused concern. I am very doubtful that the Chairman of the commission has any such authority under the National Capital Act passed by this Parliament.

PRIME MINISTER'S SUMMER RESIDENCE

Hon. Marcel Lambert (Edmonton West): Is the Acting Prime Minister also of the opinion that the Chairman of the National Capital Commission has no authority to declare that the Prime Minister's summer residence and other amenities of the office of the Prime Minister shall be eliminated at the discretion of the Chairman?

Hon. G. J. McIlraith (Acting Prime Minister): I do not want to be put in the position of giving a legal opinion on the National Capital Commission legislation, but it is quite clear in the Act that the function of that commission is to advise the government on the planning of the national capital region. The responsibility for decision is that of the government and not of the commission. The commission has certain ancillary powers to carry out certain works supplementary to the main objective.
