LOANS BY BANKS TO FARMERS, SMALL BUSINESSMEN AND FISHERMEN—POSSIBLE ENLARGEMENT OF GOVERNMENT GUARANTEE

Mr. F. Oberle (Prince George-Peace River): Mr. Speaker, my question is for the Minister of Finance. In light of the difficulties in which chartered banks find themselves due to the large increase in Bank of Canada interest rates, can the minister tell the House whether it is the intention of the government to negotiate with the banks a formula under which the government would allow a further subsidy and guarantee of repayment of loans made to farmers, small businessmen and fishermen?

Hon. John N. Turner (Minister of Finance): Mr. Speaker, I do not agree with the substance of the preamble, nor with the proposed solution. As I said yesterday, the government will be announcing its decision shortly.

FISHERIES

LOSSES SUFFERED BY ATLANTIC AREA FISHERMEN FROM STORM—GOVERNMENT ASSISTANCE

Mr. Elmer M. MacKay (Central Nova): Mr. Speaker, my question is for the Minister of Fisheries. It has to do with the effect of the severe storms on fishermen in the Atlantic region almost two weeks ago. Can he tell us what the government has been doing to delineate federal and provincial responsibilities with regard to possible aid, and what co-ordination there is in this regard at present?

Hon. Jack Davis (Minister of Fisheries): Mr. Speaker, discussions have been going on among the department here and with the provincial departments of fisheries. We have decided, for example, to make the gear that was collected last year from salmon fishermen available, on reasonable terms, to fishermen. Other measures will be announced in due course.

REGIONAL ECONOMIC EXPANSION

MULTIPURPOSE WATER PROJECT PROGRAM— PROVINCIAL APPROVAL

Mr. S. J. Korchinski (Mackenzie): Mr. Speaker, I have a question for the Minister of Regional Economic Expansion. Yesterday I put a question to the minister asking whether agreement had been reached with the provinces with regard to the water development program PFRA which would involve concentration on multipurpose water projects. Can he reply to the question today?

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): Mr. Speaker, I checked into the hon. member's question. The position is that negotiations with regard to agreements are proceeding. They have not been concluded yet with any province, but we have made it plain to the provinces at the same time that individual applications will be entertained. I am told that at least one has been approved to the point where it is awaiting my signature.

I have had discussions with my colleague, the Minister of Indian Affairs and Northern Development, and also with a number of native associations with a view to expanding the base of our activities in the manner requested by the hon. member. I hope that something of substance will emerge.
