LAUZON SHIPYARDS—INQUIRY WHETHER PRIME MINISTER WILL MEET REQUEST OF UNION PRESIDENT

REASON FOR RESIGNATION OF CRTC CHAIRMAN

Hon. Jeanne Sauvé (Laval-des-Rapides): Mr. Speaker, my question is for the Minister of Communications. As the chairmanship of CRTC is a term appointment for seven years—and rightly so, since that function requires total independence from the government of the day—I should like to know from the minister why the government decided to tamper with this rule and found out all of a sudden that Mr. Camu was indispensable as deputy minister of another department before he had finished his term. He had served only two years of a seven-year term, and I am wondering why this function was tampered with and why Mr. Camu was offered another job.

Hon. David MacDonald (Secretary of State and Minister of Communications): Mr. Speaker, I think the minister—

outside the public service. We regret that very much, but we wish him well in his new work.

Mrs. Sauvé: I am quite aware that he has taken a job in the private sector, but I would like the minister to check if he had been offered another job in a government department before he decided to go to the private sector; and I should like to know from the minister whether we can now expect to see the very competent vice chairman, Mr. Dalfen, promoted to the position of chairman or whether we will be treated to another patronage appointment.

Some hon. Members: Oh, oh!

Mr. MacDonald (Egmont): I know that the former minister is well aware of what patronage appointments are all about.

Some hon. Members: Hear, hear!

Mr. MacDonald (Egmont): I want to assure her that I have discussed the matter of Mr. Camu leaving the public service directly with him, and that it is not as has been said by the hon. member. If she wants to, she should talk to Mr. Camu directly about that.

On the second matter, in order that we can have the very best people serve in important institutions like CRTC, this government is going to consult widely and fairly before making the proper appointment.
