#### MEDICAL USE OF HEROIN

Members know, he has been the foremost spokesman on this important issue in the House. I would say the protocol is coming to conclusion. We expect it to be concluded by the end of this month. The sourcing will come from the United Kingdom. According to that source, we understand it could be available at the beginning of October, 1985.

As the Hon. Member also knows, heroin has to be put on each provincial pharmacological calendar. I have discussed that matter with the provinces and I think it is well in hand.
