Goodale (Parliamentary Secretary to President of the Privy Council): I am informed by the Central Mortgage and Housing Corporation and the Federal Business Development Branch as follows: 1 and 2. The following lawyers were retained by CMHC to process mortgage documentation for direct loans approved by CMHC in Census Divisions 5 and 9, Newfoundland, between 1970 and 1976: 1970, Corner Brook: Kevin J. Barry; Gordon G. Easton, Q.C. 1971, Corner Brook: Gordon G. Easton, Q.C. 1972, Corner Brook: Gordon G. Easton, Q.C.; Clyde K. Wells. 1973, Corner Brook: Gordon G. Easton, Q.C. Clyde K. Legal fees in connection with CMHC direct loans are paid by the borrower, and CMHC, therefore, has no record of the amounts paid to these lawyers.

1, 2 and 3. The Federal Business Development Bank makes use of the services of lawyers to act for it in the taking of security for loans and to undertake litigation on its behalf. In certain cases the lawyer is selected by the bank, in other cases the lawyer may have been chosen by the borrower. In either event, the legal fees and expenses for security preparation and registration are paid by the borrower rather than by the bank. The selection of lawyers is regarded by the FBDB as a matter of internal administration, the responsibility for which rests with the board of directors, according to the FBDB Act. For this reason, the names of solicitors employed are not made public.
