## REMINDER TO SUBSCRIBERS

We are being deluged at the *Quarterly* with CHANGE OF ADDRESS/SUBSCRIPTION APPLICATION forms which have been filled out incorrectly for renewals of *Quarterly* subscriptions. The CHANGE OF ADDRESS form, a yellow form which accompanies each issue of the *Quarterly*, is to be completed and mailed in only when a subscriber changes his or her mailing address. The SUBSCRIPTION APPLICATION (the opposite side of the form) should be used only for new applications for the *Quarterly*.

Neither of these forms should be used for subscription renewals. You will automatically receive a *QUARTERLY RENEWAL NOTICE* three months prior to the expiration of your current subscription. Follow-up notices will be mailed to you two months and one month prior to the expiry of your subscription. If we haven't received a completed renewal notice form from you after the three notices have been sent, your subscription will automatically be cancelled. If you should wish to renew your subscription at some time in the future, simply send in a completed SUBSCRIPTION APPLICATION, and your subscription will be reactivated.

Many RCMP pensioners have been requesting that their subscription fees be automatically deducted from their monthly pension cheques, as they were from their pay cheques. Unfortunately, this cannot be done. Once a member has gone to pension, if he or she wishes to keep up their *Quarterly* subscription, they must complete the *QUARTERLY RENEWAL FORM*, which will automatically be sent to them three months before their subscription expires, and return it to us with a cheque for five dollars plus 35 cents GST for each single year subscription.
