So it passed in the Negative.

And the Question being again proposed, That the Bill be now read the third time;

Mr. *Wallace (Norfolk)* moved, in amendment, seconded by Mr. *White (Renfrew)*, That all the words after "now" to the end of the Question, be left out, and the words "recommitted to a Committee of the whole House, with an instruction that they have power to amend the same by adding the following words to Section 5:—If "any Minister of the Crown shall knowingly be a party to any transaction whereby "under any of the provisions of this Act the seat of any Member of the House of "Commons of *Canada* shall be voided, he the said Minister shall void his seat and "forfeit his office, and shall be disqualified for seven years thereafter from being "appointed to, or for holding any office under the Crown" inserted instead thereof;

And the Question being put on the amendment; the House divided: and it passed in the Negative.

And the Question being again proposed, That the Bill be now read the third time;

Mr. *Bowell* moved, in amendment, seconded by Mr. *Mitchell*, That all the words after "now" to the end of the Question, be left out, and the words "recommitted to a Committee of the whole House, with an instruction that they have power to amend the same by adding the following words to Section 5: 'If any Minister of the Crown "shall knowingly be a party to any contract or agreement whereby under any of "the provisions of this Act the seat of any Member of the House of Commons shall "be vacated, the seat of the said Minister shall thereby be also vacated, and the said "Minister shall become subject to the penalties imposed by this Section,"' inserted "instead thereof;

And the Question being put on the amendment: the House divided: and it passed in the Negative.

Then the main Question being put,

*Ordered*, That the Bill be now read the third time.

The Bill was accordingly read the third time.
