mode adopted in the British Parliament, in this respect, has ever been departed from.

The report being handed in at the Clerk's Table, was there again read.

Ordered, that the report be accepted.

And on motion of Mr. Dow.—Further ordered, that the House do to-morrow go

into Committee of the whole, in consideration of the said report.

On motion of Mr. Allen.—Resolved, that an humble Address be presented to His Excellency the Lieutenant-Governor, praying that His Excellency will be pleased direct the Commissioners for superintending the erection of Government House, to accompany a Committee to be appointed by this House, to inspect the said Building and to report thereon.

Ordered, that Mr. Allen, Mr. Hayward, and Mr. Harrison, be a Committee to pre-

sent the address.

On motion of Mr. Chandler.—The House went into Committee of the whole, on a Bill to secure and reclaim a tract of Marsh on the Au Lac River in the County of Westmorland, sent down from the Council.

Mr. Scott in the Chair of the Committee.

The Chairman reported, they had agreed to the Bill without making any amendments.

Ordered, that the Report be accepted.

On motion of Mr. Crane.—The House went into Committee of the whole, on a Bill to ascertain all ungranted Lands in the Township of Sackville in the County of Westmoreland, and to vest all the vacant and unlocated wilderness Lots, within the same, in the Crown.

Mr. M'Kay in the Chair of the Committee.

The Chairman reported, that having gone into consideration of the said Bill, the

Committee had passed the following Resolution:-

"Whereas it appears that this Bill is entirely of a local nature, and tends materially to effect private rights; that there is no petition before the Legislature, praying for the same to be passed, and such Bill has never been read at a General Sessions of the Peace for the County of Westmorland; And whereas it is highly just and proper that the said Bill should be published,

"Thereupon resolved, that the further consideration thereof be postponed until the next Session of the General Assembly, and that the persons desirous of having the said Bill passed, do cause the same to be thrice published in the New-Brunswick Courier. within three months, after the end of this Session, and also to be twice read at the General Sessions of the Peace for the said County."

Ordered, that the Report be accepted, and the Resolution as reported from the

Committee, be adopted by the House.

On motion of Mr. Chandler .- Resolved, that a Committee be appointed to search the Journals of the Honorable the Legislative Council, to ascertain what proceedings have been had on a Bill for the regulating, laying out, and repairing Highways.

Also a Bill further to amend the Acts relating to Streets and Highways, in the City

and County of St. John.

Ordered, that Mr. Chandier be a Committee for that purpose.

Mr. Hayward, by leave, presented a Petition from William Cross, a Prisoner confined in the Common Gaol of the County of York, by an order of this House, he having been guilty of a high breach of the Privileges of the House, by insulting a Member thereof, and praying to be released from such confinement.

Which he read.

Ordered, that the said Petition be received and lie on table.

On motion of Mr. Hayward.—Whereas William Cross having expressed contrition for the offence committed by him against the privileges of this House,

Therefore resolved, that the said William Cross be forthwith brought to the Bar of
