Laurier at Sea.

With the meeting of the Dominion parliament after the Christmas recess the House of Commons plunged at once into the maelstrom of the naval discussion. In the ab sence of Hon. L P Brodeur Minister of Marine and Fisheries who is seriously ill, the lot fell to the Premier of introducing the legislation which is by far the most important of recent years. Sir Wilfrid Laurier contented himself with explaining briefly the main features of the bill which calls for a Canadian navy built as far as possible in Canada, consisting of eleven vessels, I cruiser of the Boadecea type, 4 of the Bristol type and 6 torpedo boats of the river class. The cost of these vessels if built in England would be according to British figures less than if they were built in Canada. In England they would cost the sum of 2.338,000 pounds sterling or a little more than \$11,000,cent must be added to the cost as given above. The speech of the Premier was characteristically hazy. 


