

The rime Minister however allowed the linisters to retain office over eight veeks and did nothing in spite of his nowledge that the House must me oon. The Prime Minister had offered ne opinions that even had the Min sters continued to retain office unti -doy, there would be nothing that could not be justified by good preced-

nt. That was not so. The only case at home of a Cabinet Minister retaining office without a seat during the term of a session occurred some 70 years ago. That was Mr. Gladstone' ease. But Mr. Gladstone himself had condemned the precedent as contrar to "the spirit of parliamentary gov erment."
