Mr. Gregg:

1. (a) To December 31, 1950— classes 1 and 2
classes 3 and 4 (less refunds to March 31/51) 1,791,483.95
Total\$4,552,886.81
(b) In 1951, to March 31— classes 1 and 2\$3,168,046.66 classes 3 and 4\$27,877.55

2. (a) The fund has been credited from appropriations with \$1,791,483.95, the amount paid to classes 3 and 4 for the period February 28 to April 15, 1950, in accordance with section 87F(1) of the act.

Total\$3,195,924.21

(b) As from July 3, 1950, the sum of one cent per day was added to the contributions payable by employers and employees to provide supplementary benefits for classes 1 and 2. This additional contribution is included in the regular stamps, meter impressions and bulk payments and is not specially earmarked in the accounts of the commission. In accordance with the statute, the amount received up to March 31, 1952, will be determined, and if the amount expended exceeds the amount received from this additional contribution the fund will be provided reimbursed from moneys parliament.

Note: Classes 1, 2, 3 and 4 are described in section 87 (b) of the Unemployment Insurance Act.
