PASSAMAQUODDY-REQUEST FOR REPORT ON NEGOTIATIONS WITH U.S.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): I think this question should be directed to the Prime Minister since it covers at least two departments. It has to do with evidence given yesterday before a United States Senate committee by Secretary Udall in connection with the Passamaquoddy-Saint John river power project. According to newspaper reports this evidence is to the effect that Canadian officials should be encouraged by the new report.

Is the Prime Minister in a position to say if the government has conducted negotiations or at the present moment is engaged in consultations with the United States on this project? Has the government had the report from the committee now sitting in Washington to which reference was made by Mr. Udall? Is the government giving sympathetic consideration to this question on the basis not only of the report to congress but the examination being made by Canadian fisheries officials?

Right Hon. L. B. Pearson (Prime Minister): There is at present an examination going on by Canadian officials and technicians as to the feasibility of this project. There have been no discussions with the United States on this matter recently, and there will not Yes, Mr. Speaker, subject to my mentioning likely be until this examination is completed.
