I should point out that even if the Combines Investigation Act were violated in some way, that violation would hardly be of assistance to the newspaper in carrying on its business.

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a supplementary question for the Prime Minister. Does he not believe that the continuation of the third largest newspaper in this country is of sufficient importance for him or one of his ministers to get in touch with the publisher of the Toronto Telegram to determine whether something can be done to keep that newspaper going?
