CEREAL GRAINS—REQUEST FOR ASSURANCE NO EXPORT CONTROLS WILL BE IMPOSED

Mr. Frank Hamilton (Swift Current-Maple Creek): Mr. Speaker, my question is for the minister in charge of the Canadian Wheat Board. Because the international and Canadian grain trade fear that government export permits will be required for all grains after harvest this fall, the Canadian Wheat Board had to turn down offers of \$5 a bushel for No. 1 amber Durum wheat. Will the minister, in order to rectify this unusual situation, give an assurance that cereal grains will not be subject to export restriction by government permit in the coming crop year?

POLICY IN NOTIFYING APPROVAL OR REJECTION OF APPLICATIONS—REFERENCE TO APPLICATIONS FOR OPPORTUNITIES FOR YOUTH PROJECTS

Is it government policy that in all federal programs which invite applications from the Canadian public, after determination of approval or rejection by the department involved the notification of approval is transmitted by letter, over the signature of the cabinet minister concerned, on ministerial stationery, whereas those whose applications are rejected are so informed by public servants in the department involved, on ordinary departmental stationery?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, this is the first time I have heard this representation. I will consider it.

Will the minister kindly inform the House whether all those whose Opportunities for Youth applications were approved were notified by letter, on ministerial stationery, signed by himself, whereas all those whose OFY applications were rejected
