TELIDON PROJECT—APPLICATIONS UNDER ENTERPRISE DEVELOPMENT PROGRAM

MR. CROSBIE—INDEXATION OF PERSONAL INCOME TAX— POSITION OF NEW DEMOCRATIC PARTY

Crosbie (St. John's West): Madam Speaker, my point of order has to do with the remarks of the finance critic of the NDP during question period, who suggested that truth was somehow lacking in a comment I had made about the NDP opposing the indexing of personal income tax. As a matter of fact, this may be a question of privilege.

I should like to refer to *Hansard* of June 2, 1980, which clearly shows that the NDP is opposed to indexing of personal income tax, an opposition which was first expressed by them in 1973. At page 1625 of *Hansard* of June 2, the hon. member for Broadview-Greenwood (Mr. Rae) asked this question of the Prime Minister (Mr. Trudeau):

While we may agree that the index is particularly regressive and we oppose its introduction—

That is what the hon, member for Broadview-Greenwood said, that he was opposed to indexing and indexing was regressive.

That was no surprise to me because in 1973 his party pooh-poohed the whole suggestion made in the Turner budget of that year. I should like to quote from *Hansard* of February 21, 1973, at page 1527 when the NDP finance critic spoke in the House about indexing in reply to the budget speech of Mr. Turner. Mr. Saltsman then said that the NDP had "reservations about the indexed income system". They did not care about the low-income taxpayers of Canada. Further on the same page he indicated that indexing was "phony". So the hon. member's indignation was certainly phony when I said that they opposed indexing.

Further on at page 1529 Mr. Saltsman said that the NDP "did not think it is a very good idea". This was the official
