REQUEST GOVERNMENT NEGOTIATE NEW CANADA-U.S.
AGREEMENT TO PROTECT POULTRY INDUSTRY—MOTION
UNDER S.O. 43

Mr. Adrien Lambert (Bellechasse): Mr. Speaker, under the provisions of Standing Order 43, I ask for the unanimous consent of the House to move a motion dealing with a very important matter.

Considering that the Canadian Chicken Marketing Agency has announced that under a Canada-United States agreement the import quota of American poultry was 22,250 tons this year and that it would be doubled next year, considering that the Minister of Industry, Trade and Commerce is issuing additional import permits and that Ontario has invaded the Quebec market with its quota, following the Quebec threat to withdraw for those reasons from the Canadian Chicken Marketing Agency, I move, seconded for the hon. member for Beauce (Mr. Roy):

That the House urge the government to renegotiate the Canada-United States agreement of October 22, to protect the interests of Canadian producers as well as Canadian slaughterhouses.

DISBURSEMENT OF QUARTERLY PROFITS OF OIL AND GAS
COMPANIES—MOTION UNDER S.O. 43

Therefore, I move, seconded by the hon. member for Essex-Kent (Mr. Daudlin):

That the government allow the oil and gas companies to retain a certain percentage of their quarterly profits, while placing the balance with the government in trust, to be drawn down by and paid to the respective oil and gas companies if and when these drawdown amounts have been expended by those companies in oil and gas exploration or certain aspects of research and development.
