noted that not all importations of this nature come to the attention of Customs officials. With over 600 points of entry across Canada, it is not always possible to examine thoroughly all goods which enter Canada.

(b) The criteria used by my Department in determining those items which should be classified under tariff item 99201-1 are based on court decisions made under the Customs Act and court decisions made under the comparable sections of the Criminal Code which deal with the sale or distribution of obscene material. Our administration strives to take into account as far as possible what Canadians in general believe to be immoral or indecent.

3. Yes. In the administration of tariff item 99201-1, my Department will continue to take into consideration the numerous and recent court decisions in this area. Also, such decisions will continue to be reflected in relevant departmental directives which are revised on a regular basis as required. In this regard, my Department will also be taking into account the findings of the Fraser Committee on Pornography and Prostitution, recently formed at the direction of my colleague, the Minister of Justice and Attorney General of Canada. This Committee's final report is expected in December, 1984.

1. Since 1978, how many projects were supported, in each province, and for what amount, under the ENFOR Program of the Canadian Forestry Service?

2. Of the original \$30 million committed to the ENFOR Program what amount remains for project support?

Hon. Chas. L. Caccia (Minister of the Environment): 1. The number of ENFOR projects (contracts) since 1978, and the amounts spent in each province, are as follows:

The remainder of the \$30 million ENFOR allocation has been spent on program management, administration and technology transfer.

2. The original \$30 million was for the first six years of the program and none remains for project support. However, part of the work funded by ENFOR is continuing under the same program name; about \$2 million will be available for project support in 1984/85.
