# Capital Trust closed its doors voluntarily on that day while I was in the House. Through discussions with Western Capital we learned that they were trying to come up with a plan which my officials advised me had a chance of succeeding. When they closed the doors they informed me after the fact. I repeat that the reason I made the statement in the House that day was because it was true.
