Question No. 431-Mr. Harvard:

Does the government intend to assume the financial obligations of World University Services of Canada, such as (a) the cost involved in the return of Canadian volunteers, (b) the payment to them of an annual bonus?

Hon. Monique Landry (Minister for External Relations): The government has not assumed the financial obligations of WUSC. All assets and liabilities of WUSC are being administered by the Receiver. CIDA has undertaken to ensure that activities and commitments under projects and programs it has been funding with WUSC continue to be carried out. As for Canadians working overseas under WUSC's volunteer program, their agreements with WUSC will continue to be honored, including return to Canada on completion of assignment and any other payments stipulated in their agreements.
