CARLETON CO. NOMINATION.

Declarations by Mr. Simms

and Mr. Boyer.

Which Were Read in Provincial Leg-

islature by Hon. J. D. Hazen.

Following are the declarations on the

Carleton county nomination proceed-

ings made by J. R. H. Simms and

Charles T. Boyer and read in the pro-

vincial legislature by Hon. J. D. Hazen:

Province of New Brunswick, County

of Carleton, S. S.: I, James Randolph Hartley Simms,

of the Parish of Kent, in the County

of Carleton, barrister-at-law, do

solemnly declare as follows:

1. That at the request of a number

of the electors of the county of Car-

leton aforesaid, I gave my consent to

be a candidate in the election which

is to be held in the month of Febru-

ary last for the purpose of filling the

vacancy of the house of assembly of

the province of New Brunswick, by

reason of the appointment of Wendall

P. Jones, Esquire, to the position of

solicitor general, and my nomination

paper was duly signed by twenty-nine

of the electors of the said county of

Carleton, before Charles T. Boyer, who

witnessed the signatures.

2. That I went to the court house

on the morning of Saturday, the eight-

teenth day of February last, after 11

of the clock in the forenoon, and

then shortly after my arrival there I

looked at my nomination paper with a

view to the filing of the same, I found

that I had forgotten to have Charles

T. Boyer, who had witnessed the sig-

natures to my said nomination paper,

to swear to the affidavit required by

the "Election Act." I then went to

the telephone and telephoned to get

the said Charles T. Boyer to come to

the court house and make the neces-

sary affidavit.

3. Charles T. Boyer arrived at the

court house at forty-eight minutes

after eleven in the forenoon. I had

spoken to Henry Golding, a Justice of

the peace, to be ready to swear the

said Charles T. Boyer, and had seen

written the jurat to the affidavit of

signatures on my nomination paper.

As soon as Mr. Boyer had come into

the room we went to the clerk's desk

where I had seen the Bible when I

first entered the court room. We could

not find it; we searched everywhere

around in the clerk's desk, in the

judge's desk and in the drawers in

the table in the baristers' room. We

could not find the Bible. We then re-

turned to a house near the school house

1. That I am the person who pro-

duced the signatures to the nomination

paper of James Randolph Hartley

Simms, a candidate to be nominated

to the county of Carleton to fill the

vacancy of the house of assembly

made by the appointment of Wendall

P. Jones, to the position of solicitor

general of the province of New Brunswick.

2. On Thursday afternoon, the six-

teenth day of February, Mr. Simms

met me at East Florenceville and told

me he intended to be a candidate at

the election by-election, and asked me

if I would take his nomination paper

and have it signed by at least twenty-

five electors of the county. Mr. Simms

also told me that he had been doing

business in the store he now occupies

in the month of May, 1885, Mr. Nixon

Fifty Years in Business.

George Nixon Will Today Complete a Half Century in

St. John's Commercial Life—St. Patrick's Day

His Anniversary.

(From Thursday's Daily Sun.)

If George Nixon, the veteran wall

paper merchant of King street, sees

Friday's sun shine, he will have done

business in this city for an uninter-

rupted period of fifty years. Mr. Nixon

told the Sun that of the merchants

doing business when he commenced,

he was the only survivor. A number

of firms now existing were founded

previous to that time, but the active

managers of those concerns at the pre-

sent time belong to a later genera-

tion. Many changes have taken place

in the business life of the city since that

time. All the business stores on King

street were below Gormley. The cor-

ner now occupied by Oak Hall was

known as "coffee house corner." There

were a few stores on that side of the

street, and none on the other side

above Gormley. Mr. Nixon began

business on Prince William street on

the 17th of March, 1855, remaining

there until 1861, when he removed to

King street, occupying a store on the

site now occupied by O. H. Warwick.

He was burned out in the big fire of

'77. Since that time he has been doing

business in the store he now occupies.

In the month of May, 1855, Mr. Nixon

opened an account with the Bank of

New Brunswick, and though many

other banks have been established

since that time, Mr. Nixon has never

transferred his account. In all

that time, he states with pride, he has
