PLANNING PROGRAMMING BUDGETING GUIDE

Motion No. 171-Mr. Broadbent:

That an Order of the House do issue for a copy of the cost-benefit study, as prescribed by Treasury Board Manual Planning Programming Budgeting Guide, on the Defence Development Sharing Program referred to by Mr. D. Mundy, Assistant Deputy Minister of the Department of Industry, Trade and Commerce, before the Standing Committee on Finance, Trade and Economic Affairs on April 1, 1969.

Mr. Yves Forest (Parliamentary Secretary to the President of the Privy Council): Mr. Speaker, I am informed by the Minister of Industry, Trade and Commerce (Mr. Pepin) that he cannot accept this motion for the following reasons:

1. At no time did the minister or officials of the Department of Industry, Trade and Commerce state that a cost-benefit study had been carried out on the defence development sharing program as prescribed by Treasury Board's planning programming budgeting guide.

2. In accepting the hon. member's previous motion in this house on April 23, 1969, which was No. 101, it was agreed to produce a copy of a cost-benefit analysis showing sales resulting from defence industry productivity program support to Canadian industry.

This analysis, which the member has already received, showed the ratio between sales achieved and projected and government funds expended on all completed projects up to the end of 1967 under the defence industry productivity program. Furthermore, this analysis is exactly that described by an official of the Department of Industry, Trade and Commerce in his testimony before the Standing Committee on Finance, Trade and Economic Affairs on April 1, 1969.

GUIDELINES ON CAPITAL FLOW FROM U.S.

Mr. Jean-Pierre Goyer (Parliamentary Secretary to the Secretary of State for Exernal Affairs): Mr. Speaker, I should like to table exchanges of letters between the Minister of Finance and the United States Secretary of the Treasury dated March 7 and December 16, 1968 which contain all the essential elements of the arrangements between Canada and the United States with regard to guidelines on the flow of capital from the United States. These letters have already been made public but are being tabled again today for the convenience of the hon. member. All other correspondence with the United States on this matter has been by way of technical elaboration. Such correspondence represents confidential communications exchanged in the course of negotiations between the Government of Canada and the Government of the United States. On this basis I ask the hon. member to withdraw his motion.
