Mr. Robert Muir (Cape Breton-The Sydneys): Mr. Speaker, my question is for the Minister of Regional Economic Expansion. I have given him notice of it. It is prompted by a statement by a Mr. Charles MacCulloch with reference to the takeover by the government. through the Cape Breton Development Corporation, of Dominion Coal Company. Mr. Mac-Culloch is quoted as saying:

We feel the government has been dragging its feet on the matter, and quite deliberately, so we're prepared to take it to court.

I ask the minister whether this assertion is correct. I ask, in addition, whether this corporation has in the past ever dragged its feet or evaded its responsibilities?

Hon. Jean Marchand (Minister of Regional Economic Expansion): Mr. Speaker, I have been advised by the Department of Justice that they are still assessing the properties of Dominion Coal Company and there have been no undue delays. Of course, the government is not ready to accept all the claims made by the shareholders. If they want to take this matter to court, it is up to them, but we will not accept any threat from Dominion Coal.
