Tariff Impacts of Free Trade

U.S. Tariffs on nursery stock are calculated by volume or value. Tariffs by value ranged from 2.2% to 11%. Fruit and nut trees, roses, orchids and foliage are duty free. Under the Free Trade Agreement, all tariffs will be removed by January 1, 1998, with ten equal stages of tariff reductions.
