1. Total car-loadings of revenue freight on the principal railways in Canada for the weeks ended April 5, 12, 19, and 26, 1924, were 210,960; for the corresponding period of 1923 they were 205,820.

2. Total car-loadings on the Canadian National Railways for weeks ended April 5, 12, 19, and 26, 1924, were 99,264; for corresponding period, 1923, they were 99,533.
