REQUEST FOR REDEEMING OF PERPETUAL BONDS

Mr. A. D. Hales (Wellington): Mr. Speaker, in view of the extremely low interest rate of 3 per cent on Dominion of Canada perpetual bonds I should like to ask the Minister of Finance whether he will consider calling in these bonds which are held mainly by elderly people and those on fixed incomes, and also in view of the fact that yesterday they were quoted at \$36?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, when people buy perpetual bonds they are buying an interest rate. In effect the bonds go on forever. The perpetual bonds issued have changed hands a great many times, and in most circumstances people generally buy at a price that will produce the kind of interest rate they want. This is the nature of perpetual bonds.

Mr. Hales: Mr. Speaker, I do not think the interest rate of 3 per cent would substantiate the minister's remarks. However, will he give those people who are in possession of these bonds the opportunity to register them and give proof of date of purchase, and will the government then withdraw them up to say the year 1955?

Mr. Benson: Mr. Speaker, one would have to look at this very carefully. For example, if the government redeemed perpetual bonds at par someone who bought them at \$47, for example, would make \$53 per \$100 invested.

Mr. Speaker: Order, please. I hesitate to interfere but it seems to me this is becoming a debate between the minister and the hon. member.
