## UNEMPLOYMENT INSURANCE

DEFINITION OF "CIVIL SERVANT"—ACCEPTANCE BY PROVINCES

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I wish to direct a supplementary question to the Minister of Labour with respect to a statement he made the other day on civil servants and the definition of employees. Could the minister advise if the province of Quebec has accepted that definition, and whether he has had any reply from any of the other provinces? In fact can he somewhat assure us that the other provinces feel that the act as it stands now, with its new definition, is acceptable?

Hon. Bryce Mackasey (Minister of Labour): Mr. Speaker, I am pleased to announce that the employees, the civil servants of British Columbia, Alberta, Manitoba, Saskatchewan, Ontario, New Brunswick and Prince Edward Island have all been included under the new act, and the fact that they have applied to come under the act indicates that they consider it a very good act.

So far as the provinces of Nova Scotia and Newfoundland are concerned they have accepted the plan, and negotiations are taking place on some technical matters. So far as the province of Quebec is concerned, whether it intends to remain outside the plan as of January 1 next is a matter to be determined by that province.

#### NATIONAL DEFENCE

## STATISTICS CANADA

ALLEGED DISCRIMINATION AGAINST ENGLISH-SPEAKING EMPLOYEES—PROMOTIONS IN IMPORT AND EXPORT TRADE SECTIONS

Alkenbrack (Frontenac-Lennox and Addington): Mr. Speaker, I wish to direct a question to the Minister of Industry, Trade and Commerce as the minister responsible for the Dominion Bureau of Statistics. The question is apropos of the Prime Minister's recent remarks on a harmonious bilingual and bicultural capital.
