### **GOVERNMENT POLICY**

Mr. Paul Dick (Lanark-Renfrew-Carleton): Madam Speaker, I know of two individual cases where people have used up their unemployment insurance funds and are the only qualified people in their area to get on one of the job creation programs under Section 38 of the Unemployment Insurance Act, yet they cannot be employed because they do not fit the criteria set out by the Government. Is it a new tenet of policy, in spite of having the right of affirmative action enshrined in the Canadian Constitution, that the Government will not give affirmative action programs specifically to help those who are in the worst economic condition?

Mr. Rémi Bujold (Parliamentary Secretary to Minister of Employment and Immigration): Madam Speaker, I believe I have partly answered the Hon. Member's first question. I agree that Section 38 of the Unemployment Insurance Act clearly specifies that workers who may work on these projects must be receiving unemployment insurance benefits. However, the government has already taken action to deal with the group to which the Hon. Member is referring, and the job creation program, whose criteria are to be announced shortly by the Minister of Employment and Immigration, will in fact be responding to the situation described by the Hon. Member.
