Hon. Benoît Bouchard (Minister of Employment and Immigration): Mr. Speaker, I have just answered the Member's question. I said on February 20, and I repeat it, that we have to apply regulations. That is what we did.

People from around the world who want to come to Canada have to respect the regulations and the laws of Canada. People have a chance to apply as immigrants. If they want to do that, we will consider their applications. There are a lot of people in Canada who want to be reunited with their families. They are waiting for decisions under the Immigration Act. We apply the Immigration Act to all Canadians.

ALLEGED DUMPING OF STEEL IMPORTS

Mr. Svend J. Robinson (Burnaby): Mr. Speaker, my question is for the Minister of International Trade. In light of the recent imposition of import restrictions on steel in the United States, the Western Canada Steel plant in Richmond, British Columbia, is being forced to compete with cheap foreign steel that is being dumped in Canada.

Due to the seriousness of this situation, why does the Minister refuse to meet with the joint union-management committee which is working hard to avoid a job disaster for Canadian steelworkers? Why will she not meet with this committee and protect the jobs of Canadian workers?

Hon. Pat Carney (Minister for International Trade): Possibly the reason I have not met with this committee is that I have not personally received an invitation to meet with them, Mr. Speaker.

I can only assure the Hon. Member that we are developing a steel policy to deal with the question of imports. Should the company feel that steel is being dumped in its market, it is perfectly free to take an anti-dumping action against the offender.

Mr. Robinson: Mr. Speaker, the Minister's office has received repeated requests for a meeting which she has refused completely.

Oral Questions MINISTER'S POSITION

Mr. Svend J. Robinson (Burnaby): Mr. Speaker, Canada's position has been undercut by unscrupulous brokers who ship cheap offshore steel into Canada and then re-export it to the United States, thus escaping American quotas. When will the Minister introduce strong measures to stop this offshore steel from being dumped into the U.S. via Canada and help save the jobs not just of Western Canada Steel but other steel producers in Canada, including those in the Hamilton region?

Hon. Pat Carney (Minister for International Trade): Mr. Speaker, I can only say that I cannot refuse an invitation that I was unaware I received. I will certainly try to meet with this committee on my next visit to Vancouver. In terms of our steel policy, it will be announced at the appropriate time.
