Mr. Nunziata: Mr. Speaker, we have been hearing considerable rhetoric from the NDP over the last hour or so, notwithstanding the fact that earlier this day they gave their undertaking and commitment that they would pass this bill, unanimously, by five o'clock, so stop the hypocrisy and get this bill passed.

Mr. Rodriguez: The only hypocrisy comes from the member who just spoke. Mr. Speaker, I wanted to conclude by flagging the concerns we had. We heard the parliamentary secretary attempt to answer. He did not answer the question as to the rationale for having this postponement and so at report stage, on division, we let the bill go and we will let it go on third reading, on division.
