Homer and Reid, negatived; House went into Committee; Resolutions adopted; reported; agreed to and Bill (No. 126), respecting the arrangement with British Columbia; presented, 395, 396. Read second time; considered in Committee; amended; reported; agreed to, 429. Motion for third reading; amendment proposed by Mr. Gordon, 442; negatived, 443; Bill read third time; passed, 444. Passed by the Senate with amendments, 516. Concurred in, 517. Royal Assent, 639.—47 Victoria, Chapter 6.
