**Debates:**—Select Committee appointed to supervise the Official Report of the Debates, etc., 7. First Report, recommending that Mr. George Simpson be appointed to fill vacancy caused by the death of Mr. G. B. Bradley, and that Mr. C. W. Boyce be appointed to the position of Assistant to the Chief Reporter, rendered vacant by the death of Mr. J. C. Boyce, and that salary be \$1,000 per annum, appointment to date from 1st August, 1898; and that quorum be reduced to five members; Report concurred in, 47. Second Report, recommending that Mr. Albert Horton be promoted to the position of Chief Reporter; that the services of Mr. J. A. Pelland, one of the translators, be dispensed with, 93. Motion proposed for concurrence in Report; objection taken; Mr. Speaker ruled that motion could not be put, 93. Motion for adoption of Second Report; amendment by Mr. Beausoleil, 125. Negatived; Report adopted, 126. Third Report, relative to rule allowing members to revise their speeches and reporting rules, 183, 184. Third Report concurred in, 185. Fourth Report, recommending appointment of J. G. de la Durantaye, 225. Fourth Report concurred in, 226. Fifth Report, recommending (1) Appointment of Mr. Wilfrid Larose as translator; (2) That the Clerk of the Committee be paid \$200 per annum; (3) That the widow of the late Mr. A. Raby, translator, be paid \$100; Report concurred in, 491. Sixth Report, recommending that Mr. Wilfrid Larose be appointed Chief Translator, etc.; Report concurred in, 719.
