**DIES IN OBJECT POVERTY**  
**KEPT SONS AT COLLEGE****Demise of Wife of Former Secretary**  
**of British Embassy at Paris**  
**Reads Like Tale of Fiction.**

Chicago, Jan. 21.—In want and penury, far from the scene of her social triumphs, Lady Florence Dunlevy Duncan Grey, wife of Lord Grey, formerly secretary of the English embassy at Paris and member of the Canadian government, whose daughter is now connected with the royal household and whose two sons are at Oxford, lies dead in Chicago. In the plain, commonplace statement of the coroner's office, "Died, Mrs. Fannie Grey, at 1486 Ridgewood court," is hidden a romantic story, whose parallel is seldom found outside the realm of fiction.

Thru her heroic self-sacrifice in giving the bulk of her income to the education of her children, Florence, now being a member of the queen's household, Alfred, who will assume the title next year, and Edward, a younger brother, who has hidden her self for the past ten years in poverty, which did not wound her pride.

Deserted by her husband after fifteen years of married life, Lady Grey sold her English friends she would retire to her Alabama estates, while her children were being educated, in order to forget her husband.

Instead of so doing she arranged that all but a few dollars of her income be sent to her children for their education, while she lived in a shabby little flat in Hyde Park and attempted to live by what she could earn by her pen.

This was so precarious a source of income that for days at a time, so her friends say, her only food was a few handfuls of oatmeal. At the same time her daughter Florence was leading the life of a court attaché at Windsor, while her sons were leading the life of Englishmen at Oxford.

At the time of her final separation from her husband several years ago, a scandal which reached the length and breadth of the British empire, broke out. Lord Grey took her to India, where at that time he was connected with the Leeward Islands.

Rushing her into the interior of the then trackless India, Florence was held captive by her father. Her mother, who has since been her enemy, retained the custody of her child, followed on the next steamer. Although practically penniless, she traced her daughter to her prison, and after a series of adventures, which seem incredible, kidnapped her and escaped with the child to France.

In a safe haven. Arriving in Paris a few hours ahead of her husband, Lady Grey placed her daughter in what proved to be a safe haven, the convent of the Assumption. Her two sons, concerning whose custody the father seemed to take little interest, were entered at Eton, and the lady carrier.

Telling her friends she intended to hide herself in America, Lady Grey came to Chicago. Since the day she landed in the city she has led a life of object poverty. Grey came of an aristocratic Baltimore family of the name of Dunlevy. An unmarried sister of Lady Grey has won fame in New York as an artist.

**UP TO THE STATES**

To Inaugurate Insurance Reform, Decision of Conference.

New York, Jan. 20.—A general decision that insurance reform should be inaugurated immediately by state legislatures thruout the country was arrived at by the insurance commissioners of several states, who conferred today with the New York legislative committee, which investigated life insurance. Conference between this committee and the state commissioners have covered a period of two days.

Senator Armstrong, chairman of the New York committee, said that there would probably be no more conferences. He said that the committee's report would be ready in about two weeks.

**IT MAY BRING TROUBLE**

Buffalo, N. Y., Jan. 20.—The officers of the Lake Pilots' Association of the great lakes today announced the receipt of a charter from the American Federation of Labor.

The Lake Carriers' Association recently announced that they would not recognize the pilots as a union signing contracts for next season.

The matter was taken up by the officers of the union, who are now assured of the united support of other organizations in the event of trouble with the lake carriers.

New York, Jan. 20.—About 150 members of the Life Underwriters' Association of New York today pledged themselves to organize an anti-rebate bureau to prevent the practice of giving or accepting rebates on life insurance premiums.

**SCOTLAND YARD SLEUTH**  
**CLOSE ON THIEF'S TRAIL****Wife of Sir Gilbert Parker Loses**  
**\$75,000 in Jewels at Carlton**  
**Hotel, London.**

New York, Jan. 21.—That Lady Parker, wife of Sir Gilbert Parker, who was robbed of \$75,000 in jewels several weeks ago in the Carlton Hotel, London, has been revealed in this city since the departure of a representative of Scotland Yard for Palm Beach, Fla. For more than a week the London detective worked in this city independent of the central office, visiting pawnshops and following other trails.

The recent political campaign in England, Lady Parker took up a temporary residence in the Carlton. She was Miss E. Van Tine, daughter of the late A. A. Van Tine, and wealthy in her own right.

Her jewels were well known and on this occasion she had in a casket in her room a part of her collection.

There came a knock at her door one morning and a well dressed man entered. At the sight of Lady Parker he apologized profusely, saying he had made a mistake, having been told that the room of the incident was thought of the incident.

Little was thought of the incident and Lady Parker went to make some calls. She returned, however, and discovered that the case and its contents had been taken. Nothing else had been obtained by a master key.

He was not in London, but the detective arrived after a week's investigation a clue was found which indicated that he had gone to Florida.

**MORE CHARGES.**

Buffalo, N. Y., Jan. 20.—Corporation Counsel Desbecker announced today that he will prefer new charges against Superintendent of Police Bull at the trial next Wednesday.

The charges already preferred allege nothing more than that the police chief had over the pension money. It is said the corporation counsel's charges will be more serious.

The mayor, as yet, has taken no action on the refusal of Police Commissioner Bull and Doherty to resign at his request.

**HISTORIC ISLAND SOLD.**

One of the Last Strongholds of France Passes to America.

Ogdensburg, N. Y., Jan. 20.—Chimney Island, in the St. Lawrence River, four miles below Ogdensburg, the historic site of Fort Lewis, one of the last strongholds of the French in North America, was sold today thru mortgage foreclosure proceedings to Merritt A. Cleveland of Lockport.

Repeated efforts have been made by Canadians to buy a half interest in the island and preserve it as an international park, the ruins of the fort being the attraction.

**TACOMA'S SCANDAL.**

Asphalt Promoter Alleged to Have Bribe Mayor Wright.

Tacoma, Wash., Jan. 20.—Fred T. Sherman was arrested in Seattle today, charged with having bribed Geo. Wright, mayor of Tacoma, to secure the sum in question. Sherman has been employed by both the Barber and Asphalts asphalt companies, and the bribery is alleged to have been committed during the issuance of an asphalt paving contract.

Mayor Wright denies having received the money. The bribery or attempt at bribery is a felony in Washington.

**MRS. GREEN TAKES BAD MONEY**  
**HAS TO STAND UP FOR CASH**

New York, Jan. 20.—Hetty Green, the richest woman in America, who is an elderly woman in the world, accustomed to handling all kinds of money, has been taken by a counterfeit coin was passed.

Mrs. Green boarded a car near her home, at 1203 Washington-street, and handed a half-dollar coin to the conductor.

"Sorry, madam, but I can't take that," said the conductor, and Mrs. Green then searched her pocket book but found she had no more.

A letter carrier vouched for Mrs. Green, and Conductor Krell rang up the fare and handed the nickel out of his own pocket.

**ORDER TO UNFUSE SWITCH**  
**CAUSE OF B. R. T. ACCIDENT**

New York, Jan. 20.—Kenneth Baxter, the engineer who was responsible for the Brooklyn Rapid Transit Co.'s switch which caused the crash of the elevated train in which a passenger was killed, surrendered himself to the police today.

The railroad officials say Baxter was ordered to unfuse the switch, which is not used in the winter months, in order that an experimental train might be sent over the Rockaway Beach division.

**Polar Search Company.**

Augusta, Me., Jan. 21.—The Wellman Chicago Record-Herald polar expedition, a corporation whose object is the carrying on of a scientific and exploring expedition to the north pole with the aid of balloons and air ships, has been organized in this city. Victor P. Lawton, proprietor of the Chicago Daily News, is president. Frank P. Noyes, proprietor of The Chicago Record-Herald, is treasurer. Messrs. Noyes, Lawton and Avel P. Hatch Chicago comprise the board of directors. The authorized capital stock of the company is \$100,000.

**Security Company Assets.**

Boston, Mass., Jan. 20.—The receivers of the First Security and Savings Co. took charge of the office today and found that the total amount of assets of the company was \$100,000.

**There'll Be No Strike.**

Scranton, Jan. 20.—It was officially announced today that there would be no strike of the Delaware Lackawanna and Western firemen.

**POLICE ROUND UP LEADERS**  
**TROUBLE'S FEARED TO-DAY****Repressive Measures in Force in Anticipation of Terrorist Attempt at Bomb Throwing.**

St. Petersburg, Jan. 20.—In anticipation of a terrorist attempt at bomb throwing on Monday, the police today conducted searches in all the large factories and also as a precautionary measure gathered in many of the leaders of the workmen whom they will detain over Monday. Heavy guards to-night began patrolling the industrial quarters and rifles have been provided to arm the police in case there is an outbreak.

It is stated that these special measures will be in force until next Tuesday. If Monday passes without disorder, the authorities are confident that tranquility will reign until the critical period of the elections to the Duma.

The street railway employees and the apothecaries have voted for a general strike on Monday, but it is believed that the decrees of the workmen's council will be only partly obeyed in the factories and commercial houses. The Moscow workmen have not recovered from the last strike and probably will not strike on Monday.

The police do not expect the one day strike on January 23 to be general, as there are too many die workers and the others are afraid of losing their positions in midwinter. The authorities have evidence that the uprisings and terrorism in Russia have been organized abroad. A bomb thrower arrested at Odessa has been recognized as a Parisian, who was under the surveillance of the French police on account of conspiracy in the international anarchist movement having its headquarters there. The agitator arrested and shot at Warsaw were mostly of foreign origin.

It is stated that the revolutionary organizations have decided to divert their activity to attempts on the lives of officials.

At Warsaw seven members of the committee of a socialist proletarian organization have been arrested. The police are arresting hundreds of persons in consequence of the threatened strike on Monday.

**PROTECT SHOES MORE.**

Why the Canadian Manufacturer Cannot Beat the Yankee.

The Slater shoe people are satisfied with present day protection. Some other competitors are not. Mr. J. S. King of the J. D. King Co. told a World reporter that he was very much surprised at the statements made by Mr. Chas. Slater of the Slater Shoes Co. in a recent interview.

"It is quite easy to understand why the Slater Shoe Company do not need protection," said Mr. King. "They have a monopoly of the market for militia shoes at a price that more than covers any loss they might sustain by competition with the goods of the United States. They are otherwise favored by the government. Shoemen of this country are desirous of a free trade government, and quite naturally, this government should look to the people in sending reasons for not disturbing the present tariff. This could be the only reason for Mr. Slater's observations on the tariff question. He would not want to fight the government."

In his interview Mr. Slater argued in favor of free trade, contending that he would then be able to command the home market and compete in the American market. The imports to Canada from the United States last year showed that over a million dollars' worth of Slater shoes were shipped into Canada and sold here.

"Why did the Slater people not have at least a partial protection, if the Canadian manufacturer could not compete with a duty of twenty-five per cent in his favor, how could he hope to compete under free trade?" As a matter of fact shoe manufacturers had a duty of 35 per cent, which was not nearly enough, considering the advantages the American manufacturer has for specialization. To the Canadian manufacturer free trade would mean annihilation. A net profit of eighteen to twenty per cent would enable the manufacturer to supply all the requirements of the Canadian consumer and also the volume of business at present done by Americans as well as giving him a chance to compete with advantage in all the foreign markets.

"Mr. Slater makes a ridiculous statement," continued Mr. King, "when he says that a reasonable reduction in the duties on raw material would enable the Canadian manufacturer to beat the American manufacturer in the foreign export market. This would make no material difference, as manufacturers already receive a rebate on all foreign goods. It is well-known that Canadian goods sold cheaper in London, England, than at home, and that American goods much better selling than at home."

The justifying question, in Mr. King's judgment, is not at all vital, as the Canadian manufacturer has not the means to reach the public that manufacturers across the line have, for obvious reasons.

**CHICAGO'S MODEL VILLAGE**  
**TO GROW AROUND STEEL PLANT**

Chicago, Jan. 21.—A model town, which will be built by the Illinois Steel Company in connection with its new plant to be constructed near Bunnington, Ill., will be named Corey, in honor of W. Ellis Corey, president of the United States Steel Corporation, the parent concern.

The town will contain, besides model workmen's dwellings, public baths, laundry, kitchen and other municipal enterprises and will have a theatre and large assembly hall for meetings of every description.

The new plant will cost ultimately twenty to thirty millions of dollars and will require ten years for its building. More than 12,000 men will be employed.

**Accidentally Shot.**

Watertown, N. Y., Jan. 20.—A. B. Ripley, a prominent business man of Watertown, was here, accidentally shot himself in his store in that place today. The charge from the shotgun, which was examining, entered his heart, killing him instantly.
