REQUEST FOR INQUIRY INTO ORGANIZED CRIME—MOTION UNDER S.O. 43

Mr. Stuart Leggatt (New Westminster): Mr. Speaker, I rise under the provisions of the same Standing Order. In view of the information revealed in last night's excellent CBC special on organized crime concerning, particularly, the Hong Kong connection, and in view of the fact that ex-Hong Kong police officers Lui Luk, Choi Bing Lung, Chen Cheung You, Nam Cong and Hon Sum have—the Five Dragons—received landed immigrant status in Canada and that extradition proceedings have been sought against Nam Cong, I would move, seconded by the hon. member for Nanaimo-Cowichan-The Islands (Mr. Douglas):

That the Minister of Manpower and Immigration conduct an immediate inquiry into the circumstances of their admission to Canada to determine whether each individual has properly complied with all immigration rules, regulations and standards and, secondly, that the minister inquire whether any charges have been laid or are pending against these individuals in Hong Kong or elsewhere, and that the minister report to the House within two weeks from this date by way of a statement on motions so that the Canadian public can be reassured that the immigration service is not being subverted.
