### BUSINESS PROFITS WAR TAX.

#### INFORMATION AS TO RETURNS BY BUSINESS CONCERNS.

On the Orders of the Day:

Mr. F. B. CARVELL (Carleton, N.B.): I wish to ask the Minister of Finance if it is possible to have a clear statement of the policy which the Government intends to pursue regarding the publication of details of the taxation under the business profits war tax. I referred to this in the House some two or three weeks ago in the absence of the Minister of Finance, and the Prime Minister said he would bring it to the attention of the minister, but I have heard nothing further about it. I wrote to the Minister of Finance giving the names of four or five companies who I know have made large profits in the province of New Brunswick. I received the reply that no returns had been filed for the first year. I have received no further information. I am not bringing this up with a view to finding fault with the answers I received from the Finance Minister, but I feel it is a matter of so much importance that the House is entitled to a straight declaration from the Government as to how much or how little information the public are to receive in reference to matters of this kind.
